The Pricing, Data Analysis, and Coding (PDAC) Contractor provides Healthcare Common Procedural Coding System (HCPCS) assistance to manufacturers to ensure proper coding of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The PDAC has reviewed the above listed product. It is our determination that the Medicare HCPCS code to use when billing the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) is:

L0172 CERVICAL, COLLAR, SEMI-RIGID THERMOPLASTIC FOAM, TWO PIECE

The code requested was L0174 which in the descriptor states "with thoracic extension". The product submitted does not have a thoracic extension therefore does not meet the description.

As discussed per our telephone conversation January 16, 2012, the entry displayed below will be end dated one day prior to the date of this letter. This product does not have a model number and for consistency the model numbers noted above will be added as a new entry.
